Admittance Checklist

As your child begins school, personnel in the office start checking off the REQUIRED paperwork as you submit it. Below is your copy of our checklist. Please look this over and work to have it completed as quickly as you can. State law requires some of these items before a child can attend school. We have included the forms for physical and vision screening for your convenience to have them completed so that you can turn them in to the office. Thank you for your prompt attention to this list.

Custody	As you will see on the Permanent Record Form, we need to

<u>Immunization</u>	Also REQUIRED by State Law, students who do not comply	
<u>Records</u>	with the immunization requirements will not be permitted to	
	continue in school. Students with medical conditions or	
	sincerely held religious beliefs which do not allow	
	immunizations may complete a waiver statement which is	
	included in this packet. Students with a signed waiver	
	statement maybe exclude from school in the event of a	
	disease outbreak. A list of required immunizations is included	
	in this packet of information.	
<u>Physical</u>	Evidence of a physical examination by a qualified Physician is	
Examination	REQUIRED within six months prior to the entrance of the child	
	into Kindergarten or moving from another state. Your child	
	will NOT be allowed to attend school until this is complete.	
	We have included the form in this packet so that it can be	
	completed before or child starts. A parent or guardian who	
	objects may submit a written statement of refusal for his/her	
	child. The statement will be kept in the student's file. Waiver	
\	forms are available in the office.	
Vision	A school vision evaluation is REQUIRED for all children within	
Examination	six months prior to entering Nebraska schools for the first time	
	or moving from another state. Evidence of this is required by	
	law. Your child will NOT be allowed to attend school until this	
	is complete. We have included the form in this packet so	
	that it can be completed before your child starts.
