Dear Parents,

The *No Child Left Behind Act of 2001* (NCLB) requires that all states create high academic standards for the core areas of reading, writing and math. The goal of NCLB is for every student to meet or exceed these standards by the school year 2014. The measure of annual progress toward these standards is called Adequate Yearly Progress (AYP). AYP is based primarily on the results of the Nebraska state assessments given to students in grades 3 through 8 and grade 11. Schools must meet the state's academic proficiency benchmarks, as well as other indicators such as test participation and attendance/dropout rate, to make AYP.

In addition to measuring each school, NCLB also requires the Nebraska Department of Education (NDE) to annually review the progress of each school *district*. Based on Nebraska state testing results, Callaway Public School was identified by the NDE as a district in need of improvement for the 2015-16 school year. A district is identified for improvement if it meets this criterion:

Does not make AYP in all grade spans within the district-elementary (grades 3-5), middle school (grades 6-8) and high school (grades 9-12)--for two consecutive years in either content area of math or reading, considering all eligible student subgroups. Two subgroups in Reading and two subgroups in Math were Not Met for three consecutive years. To be removed from the district improvement status, the district must meet the grade span achievement standards for two consecutive years. If you would like to compare achievement scores in the district to others across the state, you may access the information on the Nebraska Department of Education (NDE) *State of the Schools Report* at <http://reportcard.education.ne.gov>.

As a Title I District identified in need of improvement, Callaway Public School is required to communicate the district improvement plan strategies specifically addressing the teaching

and learning needs of low-achieving students.
